It depends on whether you opt for a burial or cremation. The average cost of a funeral and burial is \$7,360, according to the latest data from the National Funeral Directors Association (NFDA). If you get a vault — required by many cemeteries — that number rises to \$8,755. The average cost of a funeral and cremation is a little lower: \$6,260.

Funeral homes are charging approximately \$2,260 for a direct cremation, \$3,250 for a cremation with memorial service and \$5,410 for a casketed funeral with viewing and cremation.
